

## **AMST a KENTUCKY TRAILER COMPANY CONDITIONAL LIMITED WARRANTY**

Scope: Applies to new medical imaging vehicles manufactured by Advanced Mobility & Shelter Technologies, LLC d/b/a AMST ("AMST"), a Kentucky Trailer Company, and all attaching parts.

Terms: AMST warrants to the original purchaser only and not to subsequent purchasers, that AMST will provide the repair or replacement of the trailer components and equipment referenced in a valid quotation that are defective in material or workmanship under the following conditions:

1. For warranty claims made during the period of ONE year from the date of delivery, AMST will, at AMST's option, provide the replacement or repair of any of the above-referenced components and equipment that is found to be defective by AMST in material or workmanship.

2. IN THE EVENT OF A WARRANTY CLAIM, THE ORIGINAL PURCHASER MUST CONTACT AMST AT THEIR OFFICES AT 611 COMMERCE CENTER DRIVE UNIVERSITY PARK, IL. 60484 OR BY **TELEPHONE NUMBER (800) 839-0630**. WARRANTY SERVICE MUST BE PERFORMED AS APPROVED BY AMST. WARRANTY REPAIRS WILL BE PERFORMED AT THE ADDRESS LISTED ABOVE UNLESS OTHERWISE AUTHORIZED BY AMST. WARRANTY REPLACEMENT PARTS WILL BE FURNISHED FREIGHT PREPAID. LABOR COST TO REPAIR OR REPLACE WILL BE LIMITED TO THE AMOUNT OF THE ORIGINAL PURCHASE PRICE OF THE PRODUCT AND COMPONENTS. THE REPLACED WARRANTY PRODUCTS OR PARTS BECOME THE PROPERTY OF AMST AND MUST BE RETURNED TO THE ADDRESS LISTED ABOVE FREIGHT PREPAID, UNLESS PRIOR ARRANGEMENTS HAVE BEEN AGREED TO, IN WRITING. ALL OPTIONS MUST BE EXHAUSTED TO CONDUCT WARRANTY WORK DURING NORMAL BUSINESS HOURS. REQUESTS TO CONDUCT WARRANTY WORK OUTSIDE OF NORMAL BUSINESS HOURS MIGHT RESULT IN SHARED LABOR COSTS WITH THE ORIGINAL PURCHASER. IN THE EVENT REPAIRS ARE UNDERTAKEN BY ANY PARTY OTHER THAN SELLER WITHOUT SELLER'S PRIOR WRITTEN CONSENT, ALL WARRANTY CLAIMS WITH RESPECT TO THE PORTION OF THE GOODS THAT IS SO REPAIRED OR AFFECTED SHALL BE NULL AND VOID.

3. This limited warranty is valid only when the product is properly maintained per the AMST Preventive Maintenance Checklist on a quarterly basis. Quarterly maintenance services by AMST to meet this requirement are not included in the purchase price of a new trailer. AMST will provide these services when specifically contracted to do so. Failure to do proper preventive maintenance may void certain warranty claims. Trailer shall be operated in a proper and reasonable manner as stated in the Site Planning Guide. Further, this Warranty shall be void to the extent the vehicle is subject to (i) improper installation or storage; (ii) accident, damage, abuse, acts of god or misuse; (iii) abnormal operating conditions or applications; (iv) operating conditions or applications above the rated capacity of the vehicle; (v) repairs or modifications made to all or part of the vehicle without the prior written consent of AMST; or (vi) a use or application other than or varying in any degree from the specifications and AMST's instructions.

4. This Warranty does not cover any tires, medical equipment or related accessories or equipment which are not manufactured by AMST ("**Third Party Products**"). With respect to Third Party Products, AMST makes no warranty whatsoever, and, to the fullest extent permitted by law, AMST disclaims all warranties of all types whatsoever, whether express, implied or statutory. AMST's sole obligation with respect to Third Party Products is that AMST shall use commercially reasonable efforts to assign to the original purchaser any express warranty provided by the manufacturer of such Third Party Products (for clarity, AMST does not guarantee that such warranties can be assigned to the original purchaser).

5. AMST SHALL NOT BE LIABLE TO BUYER OR ANY OTHER PERSON OR ENTITY FOR ANY INCIDENTAL, CONSEQUENTIAL, EXEMPLARY, PUNITIVE OR SPECIAL DAMAGES OR ANY OTHER LOSSES, DAMAGES OR EXPENSES WHETHER ARISING OUT OF BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT AMST HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, AND NOTWITHSTANDING THE FAILURE OF ANY AGREED OR OTHER REMEDY OF ITS ESSENTIAL PURPOSE INCLUDING LOSS OR USE OF VEHICLE, LOSS OF TIME, INCONVENIENCE, EXPENSE FOR GASOLINE, TELEPHONE, TRAVEL, LODGING, LOSS OR DAMAGE TO PERSONAL PROPERTIES, OR LOSS OF REVENUES.

6. Except as specifically stated in this Limited Warranty, AMST makes no other warranties, express or implied, and disclaims all other express and, to the extent permitted by law, implied warranties, including the implied warranties of merchantability, non-infringement and fitness for a particular purpose; provided, however, if disclaiming any implied warranties is not permitted by law, then such implied warranties, including the warranties of merchantability and fitness for a particular purpose, are limited to one year from the date of purchase and thereafter all such implied warranties (including merchantability and fitness for a particular purpose) are disclaimed and excluded.

7. This One Year Limited Warranty is the exclusive warranty of AMST. The **SALES PERSONNEL** or other employees of **AMST ARE NOT AUTHORIZED TO MAKE WARRANTIES** concerning AMST products and no oral statements shall constitute a warranty by AMST. This limited warranty gives you specific rights and you may also have specific rights which may vary from state to state.
